Terms of Enrolment

Learn to Swim terms run for 11 weeks with membership expiring at the end of each term. All enrolments open week 9 of current term for following term. New enrolments can be made at any time on a pro rata basis.

Program requirements

Parent/Guardian required in the water with children until the age of 4yr. Classes booked for same day / time each week throughout term. Physical manipulation will be required at times to ensure correct development of skills.

Payments

Full-term fees have been paid at the time of enrolment, or you have the option to choose Direct Debit payments. Additional fees apply.
